Dear Parents & Carers

Grafham Water Residential Trip – 1st – 3rd May 2024

Once again we will be offering the children in Year 4 a three-day residential trip to the Grafham Water Centre on 1st – 3rd May. This year the children and staff will be staying in Grafham Water Centre's bell tents.

In order to save money we have decided to ask parents to transport the children to and from Grafham themselves (full details of times, etc. to follow). The cost of the visit is £241.20. This includes accommodation, food and full use of equipment and facilities. It will not be necessary to buy any special clothing or equipment; this will be provided by the Centre.

The cost of the trip is £241.20.

1. If you would like your child to take part in this visit, please return the slip below, together with a non-refundable **deposit of £50, by 31st October 2023**. Please make your payment via the Arbor app. By making the non-refundable deposit on Arbor, you will be giving consent to your child attending the trip.
2. Make a second payment of £64.00 to the school by **31st January 2024**
3. Make a third payment of £64.00 to the school by **29th February 2024**
4. Make a final payment of £63.20 to the school by **28th March 2024**

We are aware that many parents would rather make smaller, more regular payments. Parents are able to pay whatever amount they like, following their initial £50.00 payment as long as the totals coincide with the payment dates required as stated above. If you have any questions regarding this, please speak to the Office who will be happy to explain.

Attendance on this trip is dependent on pupil behaviour during the year. Children who are unable to behave within the school environment will not be allowed to take part, and any contributions returned (with the exception of the deposit).
